**Champions Lessons & Training For Students who Own or Lease a horse:**

*Students who own or lease a horse and show riders must be in a minimum of 2 days per week lesson/trainer contacts.*

**Champions School Program**

Students who don't own a horse can ride one day a week in a lesson using a Bronze Package or bigger package. School Program students will use a school horse and it requires a Horse Use Fee of \$50 per lesson which covers a percentage of the costs for horse care and gear. Horse use Fees are not included in the lesson packages. Taking 4 lessons a month in the school program using a school horse will cost \$200 to use the school horse outside of the cost of lesson package listed.

Champions Equestrian offers lessons (instruction of students) and training (professional trainer working with the horse on the ground or under saddle) for students who own or lease a horse.. All horses are required to be in a minimum of 2 contacts per week to ensure safety, consistency, and general wellness. Riders who are wanting to show are also required to be in a minimum of



2 days per week lessons to ensure safety and progress, even if they are riding school horses. All contacts are to be used during the month they are billed. *All packages may include training contacts or lessons with assistant trainers unless specific arrangements are made with Cynda. Packages cover the management of vet, farrier, and all appointments or other care needs.*

- **Individual Lessons** - Individual private lessons.
- **Bronze Package** - Minimum lesson package 1x per week, or 4 contacts per month. *Does not meet the minimum training requirement for horses or show riders.*
- **Silver Package** - Lessons and/or training totaling 2 contacts per week, or 8 per month.
- **Gold Package** - Includes 12 contacts per month which can be used as training rides and/or lessons.
- **Platinum Package** - Includes 16 contacts per month which can be used as training rides and/or lessons.
- **Care and Rehab** - Flat fee for any horse not in another training package due to a short-term (less than 30 days) injury or illness. Includes grooming and light rehab contacts while recovering from illness or injury. Can include medication administration not covered by barn staff, and therapy appointments.
- **CCT Session** - For healing and transformation. CCT sessions create openness which is the state of allowing, without resistance. On an energetic level, it's a state of accessibility that allows things like information, healing, grace, right timing or clarity to come in and support us. Horses are incredible because they hold space for people, a safe haven without judgment. Horses can help you breathe, become grounded and find your still point. They reflect the beautiful things you love about yourself and are grounded in who they are in this world.

### **Supplements**

Dynamite and LifeVantage Supplements are available for purchase through Champions Equestrian if needed.

Any incurred emergency vet supplies will be billed at cost at time of service.

### **Sales and Leases**

A 3-month \$1500 retainer agreement is required for the sale and/or purchase process. This amount will be applied to a commission in the event of a successful transaction, and will cover the time spent throughout the process if a sale/purchase is not completed within the 3-month time frame. Associated travel expenses (mileage, flights, hotels, and meals) are charged for trips specifically designated to look at horses for purchase or lease.

15% commission on all purchases, sales, and leases on amounts of \$100k and below

10% commission on all purchases, sales, and leases on amounts over \$100k

### **Consultation Fee** (\$50 per half hour)

Assessed at trainer's discretion for extensive consultation on specific topics (training packages, showing, saddle fit, vet and/or farrier care, horse shopping without purchase, etc) outside of lesson time.



### **Cancellation Policy**

Students MUST give 24 hour notice of cancellation in order to qualify for a make-up lesson. This 24-hour cancellation policy will be strictly enforced. If you are not able to provide ample notice to cancel your lesson, you will be charged your normal price for your time slot. If you are late to your lesson, your lesson will be shortened accordingly. Poor weather conditions or lameness of horses will result in lessons being rescheduled.

Lesson packages must be used within the month they are purchased. Exceptions are at trainer's discretion only.

### **Late Payments**

Invoices are due on the 1st of the month. Payment is requested via auto-payment through credit card will include a 3.3%, Venmo 2%, ACH 1% electronic transaction fee. Payment may also be received by check no later than the 5th of the month but will include a 5% deposit fee. **Any payments received after the 5th day of the month will be assessed a late fee of \$100 and suspension of all training services until the account is paid in full.**

Save money, avoid late fees, and minimize any disruptions to your Champions Equestrian training services by signing payment authorization.

### **Termination and Refund Policy**

Either party may terminate this agreement at any time with a 30-day written notice to the other party. **Prepaid services are non-refundable** and will be completed with professionalism. Upon the termination of this service agreement, any outstanding invoices will be charged to the card on file unless a check or cash is delivered to close the account, Venmo and ACH transfer also accepted.



## Horse Shows

Champions Equestrian offers a complete competition schedule for the local CHJA circuits. Additional competition opportunities and outings may be available throughout the year, including gymkhanas, cross country schooling, ranch sorting, an annual pair pace, and trail rides.

### Single Day Show Expenses Per Horse

#### *CHJA shows*

- 1) Coaching (\$150 per day/per division)
  - 2) Hauling (\$100)per horse for the first 25 miles. Trips over 25 miles will incur an additional charge of (\$1.75-\$2.00) per mile per horse.
  - 3) Third Party Expenses (entry fees, braiding, on-site vet care, on-site farrier services, etc)
  - 4) *Optional*: Professional Show Rides (\$50 per class)
  - 5) *Optional*: Day Care (\$50 per horse) - applied automatically if owner is not present at show; also applied at trainer's discretion if trainer(s) provide care, food, and water at show

### Multiple Day Show Expenses Per Horse

#### *Example: Copper Penny in Estes Park*

- 1) Administrative & Set Up Fee (\$50)
- 2) Hauling (\$100)per horse for the first 25 miles. Trips over 25 miles will incur an additional charge of (\$1.75-\$2.00) per mile per horse.
- 3) Coaching (\$150 per day/per division)
- 4) Day Care Fee (\$75 per day) - Covers feeding, watering, stall cleaning, night check
- 5) Third Party Expenses (entry fees, braiding, on-site vet care, on-site farrier services, etc)
- 6) *Optional*: Professional Show Ride (\$50 per class)

### Multiple Day Show Expenses Split Among Clients

- 7) Tack/Grooming Stalls
  - 8) Feed & Bedding
  - 9) Travel, accommodations & food for trainer, assistant trainer, and grooms

### Non-Show Outing Expenses Per Horse

#### *Example: Cross-country schooling, ranch sorting, sale showings, vet clinic appointments, etc*

- 1) Coaching (\$150 per day)
- 2) Hauling (\$100)per horse for the first 25 miles. Trips over 25 miles will incur an additional charge of (\$1.75-\$2.00) per mile per horse.
- 3) Third Party Expenses (entry fees, cow fees, location access fees etc)

**WARNING:**

Under Colorado Law, an equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Section 12-21-119, Colorado Revised Statutes.

1. Participant has requested to participate in equestrian classes and/or workshops conducted by Champions Equestrian (the "Activities"). Participant understands that participation in physical activities involving horses, facilities, equipment, and other riders presents some unavoidable risk of injury, including physical injury from Activities, aggravation of pre-existing conditions, slippery surfaces, animal behavior, inadequate or misunderstood instructions, and/or personal mistakes. Participant also understands that there are unavoidable risks associated with bad decision-making, inattention, conduct of other participants, misuse or failure of equipment, and other forms of accidents that cannot be foreseen. Participant recognizes that risks of injury, death, disease, virus, exposure, or other forms of risk cannot be fully avoided. Participant acknowledges and accepts all such risks. Participant also consents to physical contact associated with the Activities. Participant accepts all risks and hazards, both foreseen and unforeseen, involved in the Activities, up to and including physical injury and death. Participant consents to any action by Champions Equestrian to provide prompt medical attention in the event of any perceived medical emergency.

2. Participant acknowledges that Champions Equestrian may have additional policies and procedures enacted to protect the health and well-being of Participant and others. Participant agrees to comply with all enacted policies adopted by Champions Equestrian.

3. Participant represents that Participant is physically fit and competent to participate in the Activities, and that Participant is unaware of any physical or mental condition that would prevent Participant from safely participating in the Activities or endanger Participant's health and safety or the health and safety of others. Participant understands that it is Participant's responsibility to consult with a physician before any such Activities, and Participant must inform the instructor of any injury or condition that might affect Participant's ability to safely participate.

**4. Participant knowingly, voluntarily and expressly waives and releases any direct or derivative claims Participant or anyone on behalf of Participant may have against Champions Equestrian Inc., along with its employees, owners, contractors, instructors, or landlords, for physical or emotional injuries, property damage, financial loss, consequential or incidental damages, death, or any other form of damages that Participant may sustain as a result of Participant's participation in Activities or presence at Champions Equestrian, including but not limited to any claim of negligence, recklessness, or intentional conduct arising from any activity, facilities, equipment, or programs. Participant agrees to indemnify, defend, and hold harmless Champions Equestrian Inc., along with its owners, employees, contractors, landlords, or agents for any claim or suit arising from the negligence, recklessness, or intentional conduct of Participant.**

5. Participant understands that Participant has no claim against Champions Equestrian Inc., by reason of Champions Equestrian's refusal to allow Participant to participate in the Activities, other than a possible refund of those monies paid by Participant for the refused activity.

6. Champions Equestrian Inc. shall not be responsible or liable for any articles lost, stolen or damaged in or about the facility.

Participant authorizes Champions Equestrian to use, disclose and market information pertaining to Participant, including names, photographs, images, likenesses, video recordings, activities, business names, logos, locations, business descriptions, and relationship with Champions Equestrian, for any purpose and without any



expectation of compensation to Participant. Participant waives any claim of intellectual property rights of ownership or royalties, whatsoever, in any marketing materials of Champions Equestrian. Any and all rights of ownership in intellectual property as described above are irrevocably assigned to Champions Equestrian Inc..

8. This Agreement is governed by Colorado law. If any provision of this Agreement is or becomes invalid or unenforceable in whole or in part, such provision shall be deemed amended to conform to the requirements of the law so as to be valid and enforceable.
